

Privacy and Personal Data Protection Policy

("Privacy Policy") WeTrade Capital Limited

1. Purpose of this Privacy Notice

WeTrade Capital Limited (hereinafter referred to as "WeTrade" or "the Company" with Licence Number: MB/22/0100, regulated by the Labuan Financial Services Authority, with its registered office at Unit Level 9F (2), Main Office Tower, Financial Park Labuan, Jalan Merdeka, 87000, Federal Territory of Labuan, Malaysia, collects your personal information when you register to use our platform (hereinafter referred to as "Platform"), access WeTrade websites, mobile applications, or other services we provide, or otherwise contact us online (collectively, "Services"). By using these Services, you agree to the terms of this Privacy Policy. If you do not agree with this Privacy Policy, please refrain from using the Services.

This privacy notice aims to give you information on how WeTrade collects and processes your personal data through your use of this website, including any data you may provide through this website when you sign up to our website, please advise how the data collected through the website of WeTrade.

We reserve the right to amend this Privacy Policy, so please check periodically to stay informed of any changes. Your continued use of the Services following any modifications to the Privacy Policy signifies your acceptance of those changes.

This Privacy Policy details our collection, use, disclosure, and/or processing of personal information provided by you or collected through our websites and mobile applications. We will collect your personal information in accordance with applicable local laws and regulations, including but not limited to the Labuan Financial Services Privacy Act 1996.

This Privacy Policy applies only to the services where it is made available by WeTrade and does not extend to third-party websites, networks, or platforms to which we may provide links. Please be aware that WeTrade is not responsible or liable for the contents or activities of those third-party websites, networks, or platforms, nor their privacy policies. We do not guarantee the security of any personal information disclosed to or collected by those third-party services. Please review the privacy policies of any third-party websites, networks, or platforms before submitting any personal data to them. Accessing and providing your personal information to those third-party websites, networks, or platforms is at your own risk.

1.2 If you fail to provide Personal Data

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter with you (for example, to provide you with goods or services). In this case, we may have to cancel a product or service you have with us, but we will notify you if this is the case at the time.

2. Information Collection

2.1 Timing of Collection

WeTrade collects your personal information at various points when you utilize our Services. Generally, personal information is collected when:

- You use our services;
- You create an account;



- You view advertisements within our services;
- You subscribe to our newsletter;
- You contact WeTrade's client service or during technical support sessions;
- You enter WeTrade's contests or promotions;
- You interact with other users of the Services via the Platform or on WeTrade's websites or mobile applications;
- You participate in a beta or trial version of the Platform;
- You share content on or contribute to our social media channels and community websites.

2.2 Extent of Collection

We will only collect, use, disclose, and/or process personal information as reasonably necessary to fulfil your requests or for purposes of which you have been notified.

2.3 Consequences of Non-Submission

Failure to provide requested personal information may limit our ability to provide you with our Services, including processing your account creation, registration for contests or promotions, or clientservice and technical support requests.

2.4 Right to Withdraw Consent

You have the right to withdraw your consent at any time. However, withdrawing your consent may result in the termination of your Account at WeTrade and/or cessation of our provision of Services to you.

3. Types of Personal Information Collected

3.1 Categories of Information

We collect the following categories of personal information:

- **Registration Information:** Including your first name, surname, country of residence, gender, date of birth, email address, username, and password.
- **Transaction Information:** Including your postal address, telephone number, and payment information when requesting information or using our Services.
- **Public Forum Information:** Information provided in public forums on our Platform, websites, and applications.
- **Communication Information:** Information sent either one-to-one or within a limited group using our message, chat, post, or similar functionality, where legally permitted.
- **Location Information:** When visiting our websites or using our applications, including data from mobile devices interacting with our websites or applications, or associated with your IP address, where legally permitted.
- **Usage Data:** Including your device identifier or IP address, when visiting our websites, using our applications on third-party websites or platforms, or opening emails we send.

4. Methods of Collection

4.1 Personal Interaction

We collect personal information when you use our Services, request information, register an account, participate in public forums, respond to client surveys, or interact with us via one or more devices.

4.2 Technological Means



We collect information through technologies such as cookies, Flash cookies, and Web beacons when you visit our websites and applications or use our applications on third-party websites or platforms using one or more devices. Refer to our Cookie Policy in Appendix 1 for more details.

4.3 Information from Other Sources

We may acquire information from other sources to update or supplement the information you provided or that we collected automatically. Under local law, we may be required to ensure that you have authorized the relevant third party to share your personal information with us.

5. Purpose of Collection, Use, Disclosure, and Processing

5.1 General Purposes

The personal information we collect may be used for various purposes, including but not limited to:

- Facilitating the use of our Services;
- Communicating with you about your Account or transactions with us;
- Sending you information about features on our websites and applications or changes to our policies;
- Sending offers and promotions for our Services or third-party products and services, with your consent;
- Personalizing your content and experiences on our Services, websites, and mobile applications;
- Providing targeted advertisements based on your activity, with your consent;
- Processing your registration and participation in competitions, contests, promotions, seminars, and events organized or co-organized by WeTrade;
- Optimizing or improving our Services and operations through research, analysis, and development activities;
- Detecting, investigating, and preventing activities that may violate our policies or other illegal activities, including fraud prevention, anti-money-laundering, and anti-terrorism financing procedures.

6. Disclosure of Personal Information

6.1 Disclosure to Third Parties

Subject to applicable law, we may disclose your personal information to third parties for the above purposes and in the following scenarios:

- Where you elect to share your personal information with third-party companies for offers and promotions;
- Where you direct us to share your personal information with third-party websites or platforms, such as social networking websites;
- When companies perform services on our behalf, such as client service, ensuring these companies process your information only for requested purposes or as required by law;
- When sharing personal information with third parties in connection with business sales, enforcing our terms and policies, ensuring guest safety, protecting our rights and property, complying with legal processes, or when disclosure is required by law.

6.2 Privacy Practices of Other Companies

Once we share your personal information with another company, the information received by that company may be subject to its privacy practices.



7. Your Controls and Choices

You can exercise controls and choices regarding our collection, use, and sharing of your personal information. This may include the right to correct, update, or delete your Account in accordance with applicable local law. We will process your request within a reasonable time and notify you if additional time is required. This Privacy Policy incorporates elements from the General Data Protection Regulation (GDPR) for users in the European Economic Area.

8. Data Security, Integrity, and Retention

The security, integrity, and confidentiality of your personal information are paramount to us. We have implemented technical, administrative, and physical security measures to protect your personal information from unauthorized access, disclosure, use, and modification. Despite our best efforts, no security measures are perfect or impenetrable. We will retain your personal information only as long as it is necessary to fulfil the purposes for which it was collected or as required by law.

9. Data Transfers, Storage, and Processing Globally

We operate globally and may transfer your personal information to related corporate bodies or third parties worldwide for the purposes described in this Privacy Policy. We will take reasonable steps to protect your personal information and comply with applicable local data protection laws during such transfers. This includes obtaining your consent where required and ensuring overseas recipients provide a comparable standard of protection for your personal information.
